## AGREEMENT TO OUR LEGAL TERMS

These Terms of Service for **IntoClimb** ("company", "we," "us," or "our") constitute a legal agreement between you and us, governing your access to and use of our platform and related offerings (the 'Services').

We operate the website [intoclimb.com](http://intoclimb.com) (the "Site"), the mobile application IntoClimb (the "App"), as well as any other related products and services that refer or link to these legal terms (the "Legal Terms") (collectively, the "Services").

These Legal Terms constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you"), and IntoClimb, concerning your access to and use of the Services. You agree that by accessing the Services, you have read, understood, and agreed to be bound by all of these Legal Terms. *If you do not agree with all of these legal terms, then you are expressly prohibited from using the services and you must discontinue use immediately.*

## **10. SOCIAL MEDIA**
